### A. <u>Certificate of Appreciation</u>

### Eligible Candidates

- □ May be an individual member of a member organization.
- □ May be a member organization in good standing.
- □ May be an individual not a member of the N-SSA.
- ☐ May be an organization not a member of the N-SSA.
- □ Certificate of Appreciation recipients are eligible for successive certificates.

#### **Eligibility Factors**

□ Contributions of a significant, though short term duration, that has been a benefit as noted above.

#### B. **Distinguished Service Award**

#### Eligible Candidates

- ☐ Must be a member in good standing of a member organization of the N-SSA at the time of nomination.
- □ Must have been a member in good standing of a member organization or organizations for at least five (5) years.
- □ Recipients of Distinguished Service Awards are eligible for successive Distinguished Service Awards.

#### **Eligibility Factors**

- □ Contributions must be significant in and of themselves, and must have had a beneficial effect on the N-SSA.
- Contributions may have been made within a limited period of time.
- Contributions may have resulted from service, or services over an extended period of time.

#### C. Award of Merit

#### Eligible Candidates

- □ Must be a member in good standing of a member organization of the N-SSA at the time of nomination.
- ☐ Must have been a member in good standing in a member organization or organizations for at least eight (8) years.
- □ Recipients of the Award of Merit are not eligible for successive Awards of Merit.

#### **Eligibility Factors**

- ☐ The following factors are to be considered:
  - 1. Contribution of outstanding service or services to the N-SSA
  - 2. Sportsmanship
  - 3. Moral character
  - 4. Leadership
  - 5. Offices held
  - 6. Contributions to skirmish activities
