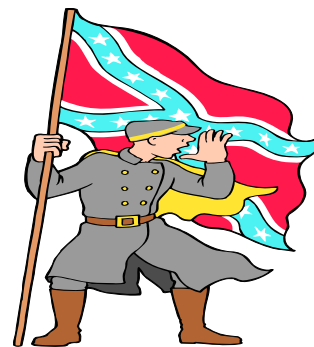

Saturday, May 3, 2008:

1. Individual matches begin at 0800 hrs.
2. There will be the one shot event to sharpen your shooting skills and have fun.
3. The Revolver match will be at 1100 hrs. The team captains meeting will be at 1030 hrs. Please remember to bring stop watches.

Events for the match are:

- 25 yd 12 pigeons on a backer
- 25 yd 8 hanging 4" x 4" tiles
- 25 yd 8 hanging clay pigeons

4. The Carbine match will begin at 1400 hrs, team captains meeting at 1330 hrs.

Events for the match are:

- 50 yd 32 pigeons on backer
- 50 yd 16 hanging 4" x 4" tiles
- 50 yd 16 hanging pigeons
- 50 yd 16 hanging water filled cups
- 100 yd 10 hanging 6" x 6" tiles

5. The Mortar Match will be 45 minutes after the Carbine match ends.

Sunday, May 4, 2009

1. Deadline for Individual protest is 0900 hrs.
2. Team captains meeting for smoothbore match will be a 0755 hrs, followed by the match at 0805 hrs.

- 25 yd 8 hanging 4" x 4" tiles
- 25 yd 8 hanging pigeons
- 50 yd 6 hanging 6" x 6" tiles

4. Opening ceremonies at 0930 hrs.

5. Musket match begins at 1000 hrs.

- 50 yd 32 pigeons on a backer
- 50 yd 16 hanging 4" x 4" tiles
- 50 yd 16 clay pigeons

Musket Continued:

- 50 yd 16 hanging water filled cups
- 100 yd 10 hanging 6" x 6" tiles

6. Repeater match to follow 45 minutes after the musket match ends.

Events for repeater match are:

- 50 yd 32 pigeons on a backer
- 50 yd 16 hanging pigeons
- 50 yd 16 hanging water filled cups
- 100 yd 10 hanging 6" x 6" tiles

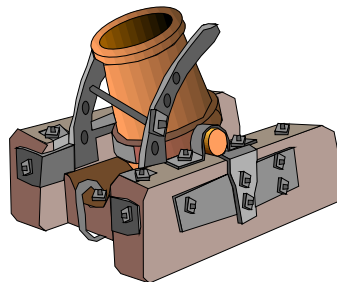
