- 25 yd 6 hanging 4x4 wood blocks
- 25 yd 6 hanging clay pigeons
- 25 yd 6 hanging water filled 2 liter bottles

Carbine Team Event 5-person team, following Smooth Bore team, about **2:15**

- 25 yd 8 wooden blocks (Triangles)
- 50 yd 10 4x4 wooden blocks
